Our Medical clinic is open by **APPOINTMENT ONLY**. No walk-ins are allowed. If you have an appointment, please call us at the office number and we will greet you at our front door.

If you do not have an appointment, please call and talk to a Client Services Director for further guidance and scheduling.

**It is important to stay home if you are sick to prevent spreading the virus.** Please help us protect our vulnerable population by answering these questions

## **Do you have any symptoms?**

- Cough
- Fever (temperature above 99.5 degrees)
- Shortness of breath, or lower respiratory infection symptoms

## **Have you had potential exposure?**

- Have you, a family member, or co-worker traveled internationally (or been in close contact with someone who has traveled internationally) within the last 14 days?  
If **yes**, where? Have you traveled to/from or through China, South Korea, Japan, Italy, or Iran or any other high-risk areas as indicated by the CDC?
- Have you had close contact with anyone who has been exposed to COVID-19 or has been confirmed with a case of COVID-19?

**If you answer YES to any of the above questions, please call the Center so we can assess risk and make appropriate referrals.**

***If our staff assesses you to be at risk, you will be asked to schedule your appointment to a future date for the safety of our staff and patients.***
